On this 14th day of August, 2019, Talina Dupree Simpson appeared before me an individual known personally to me the person that affixed his signature to this document below and being first duly sworn on this oath, hereby deposes and says:

I, Talina Dupree Simpson, am over the age of 18, am fully competent in all manners to make this affidavit. I have personal knowledge of the herein, and if called as a witness, could and would testify completely thereto.

- 1. My name is Talina Dupree Simpson. I am an African-American, Lesbian Woman that's been in poverty all of my life and have lived in government subsidized housing apartment buildings all of my life. I am a lover of human beings, always believed that all human beings should be treated with dignity and respect whether they are gay or straight, black or white, poor or rich, young or old, Christian or Muslim, etc. I graduated at the top 10 percent of my class in May 2001 at Withrow High School in Cincinnati, Ohio with a 3.3 GPA. I always felt like I could do anything I put my mind to. I worked for 15 years before my health conditions started to make things challenging for physically, which began in 2012. Most of my life, I have worked and/or went to school to be a good, productive U.S. Citizen. I have always stood up for myself and always encourage people to do the right thing in life and lead by example. I have always tried to be there for my mom and 3 brothers the best way I knew how to be because I love them and want to be a good role model for them as well.
 - My health conditions started to limit my work tolerance at this time as well I did jobs such as Fast Food worker, Retail Sales Associate, Clerical Work, and Intern as a Library Assistant, Call Center Agent, Help Desk Associate, Mail Clerk, and some PC Tech work. Around years 2010-2013 was also the years I started dealing with Gaslighting, Defamation and Harassment with Page Tower Apartments Manager William Byrd and I also started to get harassed by neighbors and on-shift security guards. Security Guards at Page Towers also harassed several of my guests that came to see me at Page Tower Apartments. Between years 2010-2011 is when I dealt with Workplace Mobbing and Harassment performed by various employees at the CVG Cincinnati/Northern Kentucky Airport when I was employed by McDonalds as a crew member and at Starbucks (HMS Host owned Starbuck at the CVG Airport at the time) as a Barista. Since I have moved to Gateway Plaza Apartments (400 West 9th Street, Cincinnati, Ohio 45203) on September of 2018, I have been dealing with noise campaign in my apartment, I have been followed by my next door neighbor who lives in Apartment 1012 at Gateway and by other male neighbors that live on my floor, above my apartment unit (Apartment 1111) and below my apartment unit (Apt. 911). I have also detected high levels of radiation throughout the pipes and walls of my apartments and have detected some sort of speakers and cameras throughout my walls and vents of my apartment. I believe that my landlords have been participants in Gangstalking and Gaslighting me since I am a Targeted Individual. It is possible could be more involved in my targeting than I think, but I don't think he was the one that had me enrolled in the targeted individual program.
- 2. Page Tower Apartments is owned by Union Baptist Church and managed by Nelson and Associates Realtors). Page Tower Apartments is located at 619 Central Avenue, Cincinnati, Ohio 45202. Union Baptist Church owns Page Tower Apartments and they are located at 405 West 7th Street, Cincinnati, Ohio 45203. Page Tower Apartments is Managed by Nelson and Associates that is located at 5181 Natorp Blvd., Suite 140, Mason, Ohio 45040. Gateway Plaza Apartments is located at 400 West 9th Street, Cincinnati, Ohio 45203. Edgewood Apartments is the Landlord for Gateway Plaza Apartments and is located at 9711 Washingtonian Blvd Suite 200, Gaithersburg, MD 20878. CVG Cincinnati/ Northern Kentucky Airport are located in Hebron, KY. McDonalds (where I was employed in 2010) is located in Terminal 3 of the Cincinnati/ Northern Kentucky Airport.
- 3. A Targeted Individual is a government term for a person that is being targeted. Is an illegal program of organized crime, although it appears that perpetrators conjecture in their mind that they are doing community policing. Many perpetrators are paid or blackmailed. These perpetrators sometime rationalize or justify in the head they doing right, although they would never confess in a court of law. Targeted Individuals are the victims of this surreptitious program often using Directed Energy Weapons and Electronic Harassment typically in conjunction

with Organized Stalking. Organized Stalking in plain terms is stalking but in a conspiracy organized with others and using wireless technology such as cellphones or handheld devices. Although the public at large does not know about Directed Energy Weapons, this is a fact now disputed by the United States Government. A Directed Energy Weapon (DEW) is a ranged weapon system that inflicts damage at a target by emission of highly focused energy, including laser, microwaves and particle beams. The targeting also includes Voice to Skull (V2K) that beam words into the head not using the ears and is usually done in sleep mode similar to dreams.

- 4. Targeted Individuals (whom are innocent) are placed on the Terror Watch list and tracked as "Non-Investigative Subjects," so that local police and sheriffs can be instructed not to assist with their emergency calls.
- 5. The CIA program, Targeted Individual is designed to completely decimate the Targeted Individual's life and psyche, as well as, extract multiple streams of profit from the victim directly and as a Human Experimentation Trafficking Subject. The family, friends, neighbors, colleagues and business partners of the Primary Targeted Individual ultimately all end up being turned into victims and used as sources of profit as well. This is done via the creation of "Control Files" that are written up about them under the pretense of associating with "a criminal." Then this "Control File" is used as leverage to subjugate them, or turn them into full-fledged Targeted Individuals themselves at some point in the future.
- 6. The more accurate term for Gang stalking or Organized Stalking is Security-Services Stalking. Security Services Stalking of a Targeted Individual involves a customized array of these kind of tactics: Blacklisting(keep target from attaining employment or income), Illegal Surveillance, Slander, Harassment, Noise Campaigns/Acoustic Attacks, Street Theatre Disconcertment Skits, Subversion of Relationships, Black-Bag Home Break-Ins, Sleep-Deprivation, Workplace Mobbing, Intelligence Property Theft, Subversion of Medical Care, Financial/Asset Sabotage, Computer/Phone Sabotage, use of Voice to Skull Technology(V2K) to trigger targeted individuals into thinking they are hearing voices, Subversion of Mail Delivery, Staged Traumatic Events or Encounters, Criminal Framing, Staged Accidents, The Triggering of Fraudulent Systemic Chain Reactions, Covert Physical Drugging or Poisoning and Physical Attacks via Microwaves/EMF (Electro-Magnetic Frequency) Weapons, Neural Monitoring weapons and RF- Microchips that have been covertly implanted in the target. Sometimes classical crimes will also committed against a Targeted Individual who is particularly resistant to the stalking including kidnapping, all manner of overt Human-Trafficking and murder.

EMF/DEW/Sonic Weapons/Remote Neural Monitoring Weapons:

These utterly surreal weapons fall under various names: Microwaves Weapons, Directed Energy Weapons (DEW), Sonic Weapons and Remote Neural Monitoring weapons. They are delivered via various covert means and are invisible, silent, and odorless and travel freely through most walls. The more advanced variety follow the target just about everywhere they go 24/7. They are shot through: Satellites, Repeaters, Microwaves, Transmitters, Transducers, Antenna Systems, Portable Directed Energy Devices, Ultrasonic, Infrasonic, Lasers, Masers, and X-Rays and sometimes work in conjunction with covert implants, nanotechnology and virus-filled aerosols. These weapons are used by Security-Services, in coordination with low tech traditional stalking techniques to virtually imprison, incapacitate and ultimately drive the targeted victim to insanity, suicide, and/or murder. Voice to Skull Technology is also used to make a target think that they are hearing voices and think they are becoming crazy so government can use it against the targets through slander campaigns and government mental facilities financially benefit from the situation as well.

The more sophisticated electronic weapons use multiple, very narrow energy beams, and sophisticated encoding designed to converge at certain specific points within the body and brain of victim to create specific effects and injury as control many functions of the targeted individual's organs such as the brain and much of the body. These surreal weapons always inflict radiation damage to the body that can induce cancer and cause victims more problems with their path including people, animals and plants that weren't targets. The most advanced type of these electronic beams that follow the victim everywhere they go and apply a remote and wireless EEG via these beams.

7. From years 2010-current, I believe that I am being targeted by private contractors such as Lockheed Martin whom is backed by government due to a kill contract that was probably made by Jeff Copeland and his son's friend Ronald. I filed a sexual harassment complaint against Ronald (who was my supervisor at the time I worked for McDonalds at the CVG Airport) who said inappropriate things to me and other female crew members that I

also witnessed. Ronald liked to sexually harassed McDonald's Female Crew Members often on his shift. I recall him saying to me that I would look cute with long hair and a dress on. I also noticed how Ronald would like to harass other female crew members as well but it was clear that no crew members had any real attraction to him, including my friend Carmalita Roper whom experience sexual harassment from Ronald as well as a crew member at McDonald's CVG Airport. I seen Ronald touch Carmalita inappropriately several times while I was on the job. I believe that I left McDonalds around the end of 2011. McDonald's and a McDonald's Female Crew member's lawyer reached out to me via mail asking me questions about Ronald's behavior when I was supervised under him. I told them my experience with Ronald and that he was the reason I left McDonald's around 2011. If I am right, the female crew member won her sexual harassment lawsuit against Ronald and McDonalds because I wrote a statement to her lawyer and McDonalds about my experiences with Ronald's behavior. Since McDonalds loss money, I believe that they blame me, which is probably why they decided to hired private contractors (Lockheed Martin) backed by government to have me Targeted as a kill contract. I remember the last thing Ronald said to me was, "Talina, I think we better be friends or else...." He was a very cocky person and I believe that it was because Ronald knew his friends Dad (Jeff Copeland) would protect him from getting into any trouble. I can recalled some employees at other restaurants such as Subway and Chick-Fil-A (at CVG) would harass me on my lunch break, whenever they would see me around the airport and at the local bus stop when I was on my way home. Some employees would call me "Dyke", "Ugly" or some of the male employees would just would give me an intimidating look when I walked pass them or vice versa. I didn't know it at the time, but I was dealing with Workplace Mobbing, a tactic used against Targeted Individuals. Lockheed Martin is in business with CVG Cincinnati/Northern Kentucky Airport. It is also possible that CVG McDonalds or Jeff Copeland have took out an illegal life insurance policy on me as well as other McDonalds employees.

- For the last 9 years, I have been bullied by neighbors with noise tampaign(neighbors would slam their doors constantly or hit their doors, yell out of their window, shoot guns on their balcony, talk loud going past my apartment door, have loud machines on in their apartment that I could hear in my apartment, put up heavy furniture or items and forcefully slam it to the floor knowing I could hear everything over my apartment unit, play their music loud, neighbors have been spraying aerosols around my apartment unit which I believe are virus-filled aerosols, etc.), stalking, verbal abuse, I was hit by a car in front of Gateway Plaza Apartments Building by a tenant(possibly staged accident)on October 3rd of 2018, I have been stalked and sometimes harassed by more than 100 civilian vigilantes whenever I leave my apartment and go to doctor appointments, to the library, to the grocery store, etc., I have been slandered when I would apply to various apartments or apply for jobs and would not get the apartment or job, if I get a job, I am harassed by employees(workplace mobbing), I have been gaslighted several times by my landlords and their staff members, I have noticed possible satellites and drones near my apartment buildings at night and noticed helicopters flying around my balcony when I am at home and appearing in places where I am present, I have detected extremely high levels of EMF Radiation throughout the walls, pipes, vents and appliances of my apartment, I have detected hidden cameras and speakers throughout my apartment as well, I strongly believe that I am being attacked 24/7 with Directed Energy Weapons that causes me sleep deprivation, various body pains and possibly damage to my brain, lungs, muscles, heart, bladder, digestive system, etc., I have suspected that someone has been coming into my apartment and rearranging, removing or modifying certain items such as my remote control(stasi tactic), I have dealt with mail misdirection, I highly suspect that my cell phones are being hacked and monitored by the NSA, and I am sure more is to come. I suspect that I and my mother have been gassed and implanted with brain transmitters, radios, retinal implants, cochlear implants, etc. while we were asleep in our Page Tower Apartments at night around years 2011-2014.
- 9. For the last 9 years, starting in 2010, I and my mother applied to several different government subsidized apartment complexes and housing projects because these apartments were the only type of apartments we could afford due to no income(blacklisted from working by government operatives apart of this program). But we got no callbacks or mailings that we were made aware of. I believe we were slandered and discredited by those who are a part of the Targeted Individual program.

- 10. In July of 2018, I begun to feel stuck in an apartment building I hated and didn't want to be in or associated with no longer. I dealt with so much up to this point. So I decided to file an Ohio Civil Charge and a Cincinnati Civil Charge against William Byrd and Nelson and Associates/Union Baptist Church/Page Tower Apartments in an attempt to get justice for what I have been through and to get help for me and my mother far as getting assistance with finding housing elsewhere. 1 week after I filed these charges, all of the sudden, I get a call from Gateway Plaza Apartments, which happens to be located a few blocks down the street from Page Tower Apartments. Gateway Plaza is also located across the street from the back of Cincinnati City Hall. I found it to be oddly suspicious that the only apartment complex that called me for an apartment in the last 8 years was only a few blocks away from Page Tower Apartments. For the last 5 years, I filed 3-4 housing complaints with HUD against William Byrd and Page Tower Apartments. I also contacted the Cincinnati Police LGBTQ Liaison, Home Opportunities Made Equal (HOME), Legal Aid of Cincinnati, OH, ACLU, LAMBDA, Human Rights Campaign (HRC) and various other organizations as well as filed the civil charges against Page Tower Apartments and William Byrd. I didn't get any assistance from these organizations.
- 11. I decided to take the apartment offered to me at Gateway Plaza (400 West 9th Street, Apartment 1011, Cincinnati, Ohio 45203) on September 24, 2018. The Acoustic Harassment and Gang Harassment seem to have followed me to my new apartment unit at Gateway Plaza Apartments.
- 12. The noises didn't start again until a week after I moved into Gateway Plaza Apartments. A lot of the types of sounds that I heard in my apartment at Gateway Plaza Apartments were the same noises that I heard when I was a resident at Page Tower Apartments. Again, I begun to hear noises such as someone picking up furniture or dumbbells and slamming it to the floor, tapping, squeaking, scratching, stumbling, buzzing and deliberately heavy steps while walking coming from the apartment unit above mines (Noises possibly coming from apartment 1111). I would also hear noises coming from the male neighbor whom lives at in apartment 1012. The man in apartment 1012 appears to be a skinny black Israeli male in his mid-20s-early 30s and slams his door often. This was the same scenario when I was living at Page Tower Apartments. Male tenants that lived near my apartment unit would slam their doors often. I also noticed that the male that lives across from him appear to be a Black Israeli as well. I believe there are several tenants on my floor that are perpetrators (aka civilian vigilantes or neighborhood Nazis) that work for the government that are instructed to keep an eye on me and also assist with torturing me with Directed Energy Laser Weapons and Noise Campaign.
- 13. I noticed a few days after I moved into my new apartment at Gateway Plaza Apartments, I didn't have any racks in my oven and some the electric plugs in my apartment didn't work and so I put in several maintenance work orders, but maintenance workers didn't come. When I called Edgewood Management (Edgewood Management is the corporation that owns Gateway Plaza Apartments), that's when a maintenance worker showed up and fixed plugs and gave me oven racks so I could use the oven. This was October 3rd, 2018. This same day, when I was leaving out of Gateway Plaza (around 2pm) and tried to cross the street, a car from the left side of me hit me on the left side of my body, which bruised my waist. When the car hit me, the right rear view mirror broke when the car crashed into me. I believe this was a staged accident provoked by the Gateway Management and those involved in the Targeted Individual program. No bones were broken luckily according to doctors at Good Samaritan Hospital Emergency Room (375 Dixmyth Avenue, Cincinnati, Ohio) whom I seen later that day. The guy that hit me happens to be my aunt's boyfriend (They refer to him as Benny) and he does live at Gateway Plaza Apartments. I was told in the past that Benny is very close with several employees in the Gateway Plaza Apartments. Office and he has lived at Gateway for years. This accident occurred 2 days before my birthday.
- 14. October 24th around 9am, 5 minutes after I left out of Gateway Plaza building (for a job interview) I noticed that a guy that I believe lives in apartment 1111 and the guy that lives in apartment 1012 started following me. One of them had his hand in his right pocket of his hoody jacket, staring at me like he had a gun hidden in his pocket that he was planning to use on me. I called the local police (Cincinnati Police, District 1) about the incident. They noticed in their system that I called the police on my upstairs neighbor because I keep hearing noises coming from their apartment. The Cincinnati Police Dispatcher (District 1) told me I shouldn't have called the police on them. I never told the dispatcher that these men were tenants in the building. When Targeted Individuals called 911 or the police, dispatchers are instructed not to assist them. I believe Cincinnati Police are involved in my gang stalking.
- 15. Til this day, I am still dealing with these Acoustic Harassment Noise Campaigns (that sounds like sound effects from a movie), Organized Stalking and Electronic Harassment and Torture. I am also currently dealing with some subversion of mail delivery (mail misdirection).

- 16. Effect on Family- Family members use to show up at my holiday dinners, but oddly, they stop coming to my gatherings and seem to be more distant from me now. My best friend (whom lives at Gateway Plaza Apartments) stop being friends with me for no good reason at all and we been friends for 15+ years. I suspect that some of my family members and associates think that I am losing my mind and have become paranoid since I started discussing the Targeted Individual program on social media (Facebook, Twitter, Instagram, etc.). My mom is the only one that has faith in me, but she doesn't like me to discuss the program much around her, so I overall have to deal with the situation on my own. Those associated with the Targeted Individual program likes for their targets to be isolated so it would be easier for them to destroy the targeted individual's life and resort to insanity, suicide or murder. I believe my family members have been manipulated with Directed Energy Weapons to pick arguments with me whenever we come into contact with each other. I spend most of my time isolated, the way perpetrators want me to be. I can't trust too many people being in this grotesque program.
- 17. Medical-I have several health conditions and some have been diagnosed over the years of my targeting. If I die in this program, I believe perpetrators of this grotesque program will instruct doctors to blame it on my health conditions, even though they know the cause will be related to the Directed Energy Weapons used to torture me. Or they may possibly have someone such as one of my male neighbors murder me to cover up their wrong doing. I have Sarcoidosis (lungs, diagnosed in 2004 at Good Samaritan Hospital Faculty Medical Center), Sleep Apnea (diagnosed in 2011 at Good Samaritan), Arthritis, Endometriosis (Diagnosed in 2017 at UC Hospital) and Interstitial Cystitis (which I believe is definitely being caused by the Directed Energy Weapons). I am highly concerned that these military weapons are targeting my brain, my bladder, my lungs, heart, stomach, muscles and possibly other areas. I am also concerned that they are targeting my mother with these military weapons as well. I do believe that other family members of mines are at least being manipulated by these Directed Energy Weapons as well. During my surgeries, I suspect that I have had additional Rf-Microchips implanted in those areas (my laparoscopy surgery at UC Hospital to confirm I have Endometriosis in 2017, my Gallbladder removal surgery at Good Samaritan Hospital in 2016). I suspect that upon my death government will have these implants covertly removed without a trace.
- 18. I highly suspect that microwave weapons that are attacking me will make me more ill in some way and more sleep deprived. I do believe it's possible that voice to skull is being used also and possibly remote neural monitoring weapons as well as lasers handheld devices. Around March of 2019, I have notice an object in the sky at night near Gateway Plaza Apartments. It seems to be a satellite positioned to do something when it's near my bedtime. I often wake up with pains and tense muscles. I have also sighted drones near the balcony of my apartment at Gateway Plaza Apartments.
- 19. I have never had a criminal record a day in my life and have always been a law-abiding US citizen since birth. There is no real reason why I should be on the Terror Watch list as a non-investigative subject. I know no terrorist and I am not a terrorist.
- 20. I would never commit suicide or intentionally harm a soul in this world. I have respect for humanity and I have so much to live for. God and my mother have always been my motivations to be a decent human being in this world.
- 21. Since 2012, I haven't been able to attain consistent income. I have apply several times for social security benefits over the years but was turned down. I believe I have been denied benefits because traitors in government are targeting me.
- 22. If upon my death any of my past employers, family members or any one else receive any compensation, they may be the primary reason I have been targeted. I never signed a will or life insurance policy okaying anyone to financially benefit from my death.
- 23. I would like for people I have been in association with to be informed that they may be targets and should be checked for implants.
- 24. Targeted Individuals deserve an apology, admittance, and compensation from the United States government for failing us and destroying our health and lives with these sickening torture programs.

I declare under the laws of the United States and State of Ohio that to the best of my knowledge and belief the information herein is true, correct and complete.
