This office was notified of an HCSO employee finding on their vehicle a flyer. The employee picked up the flyer and became ill. Due to this the employee was transported to the Hospital for treatment. It was later determined that this employee had come into contact with Fentanyl. It was later found several more flyers were placed on the other vehicles' windshields.

A photograph of the flyer was taken and submitted to this office. According to the flyer it was calling attention to first responders being tracked by the use of microwaves by the CIA and United States Air Force. It showed on the flyer two websites. This office notified the Fusion center of the incident. The Fusion center stated at this time, HCSO is the only agency that has been targeted. The Fusion Center checked both sites and believed that they are not a cyber-threat. JTTF also was notified of the incident. They stated that this group has no history of targeting Law Enforcement. They further stated that no attacks of this kind have been report today.

The office reviewed both sites. The first site reviewed was to a group called Targeted Justice. They claimed to be 501(C) non-profit group. The group claimed to focus on bringing awareness to any individuals that might be attacked. In their opinion the threat is from microwaves being used on U.S. citizens by the CIA and U.S. Air Force. According to the website, their mailing address is shown to be Peoria, Arizona. The flyer that was used was found on the website.

The other site listed, showed to belong to a Richard Lighthouse. According to the website he is an author and a former employee of NASA. His books are on microwaves attacks. His books are sold on Amazon.

Additional intelligence obtained from other sources includes the following:

- Recommend the employees be told to stay off these two websites.
- Social media will be monitor for any mention of this incident.
- The Fusion Center, FBI and JTTF will continue to monitor.
- At this time there is no intelligence indicating that anyone involved with the organization is involved with this incident.
- Fusion Center has requested to put a preservation order these websites. Requesting information on who visited these sites recently.
