I have been a licensed massage therapist since 2010. I work at a spa and own a massage business. I also have an Associates in business. I have had many experiences which I could write about, but I will stick to the ones for which I have evidence.

*I, Lila Christina Polutta, am over the age of 18, and am fully competent in all manner to make this affidavit. I have personal knowledge of the facts herein, and if called as a witness, could and would testify completely thereto.*
