Affidavit

At the age of 23, in 1978 I was hired as a female airline pilot. One of a very few at that time that we're flying jets at a major air carrier. There were females in the military but the few females that were part of major air carriers were mostly flight engineers, but I was at the age of 23 in a major air carrier as a jet pilot.

I trained and flew as Captain up to the year 2016. My greatest achievement was Captain in the MD-11 for eight years flying worldwide operations. During that period of time I flew as Captain in the civil reserve Air Force. During Iraq freedom, I flew into Kuwait. I have medallions and certificates of appreciation from the United States government for participating in the war.

My education is a four year degree in aviation management. I was a member of the airline pilots Association for 35 years. I was head of the legislative committee of the airlines pilot association in the 1980s. I started a grassroots effort that ended in a new law being introduced to aid union negotiations during corporate bankruptcy. In the 1990s, I help start a union at one of the companies that I was flying at. The membership voted for the airline pilots Association to be joined at that airline. I flew over seas through out Africa, for Ethiopian Airlines as Captain. I was hired trained and passed all simulator and relevant tests to begin flying in South Africa, based out of Johannesburg and Cape Town. Until I was not granted a foreign work visa in a timely manner which effected the work contract.

I am a targeted individual. To the best of my knowledge the targeting began after my divorce in 2008. I do not know the reason why I am a targeted individual, but my speculation is union involvement and union leadership during my aviation career.

The directed energy weapon affects upon my body for the last nine years have been feeling as if I am hit on every part of my body. When it is heat generated it is targeted towards my back, and the right side of my face. My back had a very large red sore from the heat when it first happened. The right side of my face it becomes totally red many times during the month. My eyes water all the time and feel as if they've been hit. The back of my neck feels as if it is the main source of the attacks. I am being choked all the time, the feeling is as if my tongue is being moved not by me. The biting down of my tongue, and my teeth hurting. They can actually use my vocal chords to make odd noises, and blow air into my mouth as if a ball of air is passing through my mouth out my lips. The sexual activity is constant. I wear protective pads to try to deter the sexual assaults. I have been hit in the knees, ankles, Scratched, tendinitis, nostrils hurt, and if I'm holding something I would without trying to have the item be released from my hand. Coughing all the time, itching, cold sensations, heat sensations. Muscle spasms mostly in my legs. Total lack of sleep, urine stream stopped, constant noises that have nothing to do with the location. Such as walking on the roof or up a wall. Phantom sightings that are fake, residual sighting of what might of just occurred, and dizziness with pushing towards one side or the other of my back.

The V2k started gradually and then became full-time. It is a torture that I would not wish on anyone. The communication is also made out loud. So that neighbors could hear what my private thoughts are being repeated out loud. They have also interfered with my dreams place dreams and nightmares in my mind while I sleep, made my heart beat faster, feeling of nervousness, affected my moods, shown me graphics of guns, of me committing suicide, please note that I would never consider committing suicide. Many times being told I would be kidnapped, murdered, and asking for large amounts of money to stop the torment.

Gang stocking: I cannot go outside my home without a neighbor coming out and making some type of disrespectful movement or sign. I am out front of my home or even in the front window of my house which i have privacy film on. The gang stalkers will drive by and turn and wait at the corner . Constantly having cars follow me wherever I go, people making gestures, a lot of police activity everywhere I go, the police stopping at areas for traffic or having some type of a speeding stop. Everywhere I go the firemen drive-by or when I go to the grocery store the fire truck is always there or police are out driving around near there this is every time I go outside the house. I have photos of police and fire fighters inside grocery stores following me, the street theater is everywhere I have pictures of photos of all. In the grocery store is mainly where all the theater takes place. Blocking me in a aisle. Of course if I think of a grocery item in the store everybody's goes to that aisle and right in front of that item. Having the general public being told lies about me so that everywhere I go, I have to put up with not only gang stalking but the general public acting as if I have done something so terrible.

Invasion of privacy: I have voice recording's of people in my previous home while I was not at home, a lot of just juvenile delinquent type mischief. Family Services letter. I received a letter from the government family service stating someone said I was being abused. The letter was dated on the third and said I had to respond by the third which was the same day it was written. This is indicative of gang stocking mode of operation. I did call the family services representative and said yes, I was being abused. She said she would have the police drive by as she laughed. She never returned any calls for an appointment to be made in person. I still possess the letter. My car has been broken into, the car seat position different, and it was unlocked after I made sure it was locked. Weird stuff happens with my computer, and my iphone, stuff like things moving around without me doing it, and during this last week flashing lights have started every so often.

My perpetrators seem to be hired from the local area. To follow me and perform street theatre. I have a great volume of pictures and video. Of some people stalking me and their cars. One time I parked at Walmart, waited till the perpetrators pulled in and parked. Then after they walked into the Walmart, I got out and said out loud into my phone their car plate numbers. About a minute later they all came out of the Walmart without buying anything and got into their cars and drove away. Just a note, as I am working on this, my laptop is messing up and behind me out loud is a repeat voice stating what I am typing.

The worse thing of all is the involvement of my family. They know what is happening, yet will not talk about it, or they deny what is happening. For a long time, I thought it was a haunting, not knowing about gang stalking. Most of my family, laughed and now will not communicate with me. All my friends, will not communicate, or just laugh at me. The neighbors all have been lied to, and do what the gang stalkers tell them to do.

I have been mobbed at work, I have some photos of the disrespect, that my boss has done, and fellow employees have done. I was fired after a training period, because two employees lied about me. This was at a non-aviation job I was training for this last year.

The effects on my finances has been great, I spent a lot of money trying to stop what was happening to me. At the time I had not heard of a targeted Individual. I am now a retired person, and my only income is social security.

In the beginning of this torment, I use to call the police, I do not do that any more. I just get laughed at or told I need to see a Doctor, they always state there is no evidence. Then the policemen repeat something I have thought of in private, and never told anyone. Making sure that I know, they know of gang stalking.
