AFFIDAVIT

My current legal name is Steven E. Gammill and my current address is 15720 Montesino Dr. Orlando, FL 32828. I am presently 43 years of age, and my current address of residence is located in Orange County, FL. I, the Affiant submits and writes these statements of and on my own free will and on behalf of myself, Steven E. Gammill. I, the Affiant states that I became a victim of gang stalking (TI, targeted individual) and electronic torture.

I, the Affiant states that I have been tortured by ELF / EMF microwave technologies; Several times I am hit all night long from this technology for hours at a time. I had blood coming from my eyes several times from the radiation levels. I was told they were going to do this to me online with Facebook and have all the screenshots to prove it. I had a private investigator come in and she ran a report, the conclusion was that my house is toxic from EMF microwaves hitting me. I have the report available upon request. I have lost many jobs because I am kept up all night from these attacks and someone would not let me sleep at night. I lost my business because I had drones flying over my head at one of our locations with Wyndham resorts. I believe someone in our government has labeled me a domestic terrorist when I am simply a conservative Christian. Several times these waves of electricity has gone up my back side of my skull to hit my brain all night long, I was in almost a coma state for 3 days after this happened. I also get burns on all my private parts and have areas where I am getting attacked / burned in several different areas of my body. I believe this is happening because of a ministry I had on Facebook. This all started when Adam Donaldson from Shelby, South Carolina, pretended to be another Christian friend (really an online shill) on FB told me to open the door to my home and look at the harvest golden moon. This was at the time of the 4 blood red moon tetrads were occurring. I have gone to my parent's home in Spruce Creek, FL and have been tortured over at that location also several times. When they are done they beep my phone 3 times to let me know they are done torturing me. I also have several screenshots that will prove these online shills were listening to me in my home through Facebook. One time my entire backyard filled up with a "chem-cloud" and I immediately called the police to report it, I have pictures of the PVC pipes my neighbor used to try to poison me. I have been poisoned 4 times now and was not able to eat for 1 ½ weeks' time, each time I was poisoned, My animals are also hit with some type of laser device cutting through to their muscles leaving a perfect 1-inch diameter hole in their bodies. My Sister, Patti Benner of Batavia, IL has several screenshots also and will testify this happening to me. Along with all of this occurring I have had several death threat phone calls. I the Affiant states that I have made formal police reports to: Orange County Sherriff Office, I have contacted my states attorney general, Senators, Washington D.C., etc. and receive no support.

I the Affiant have been arrested, forcibly placed in a mental hospital, physically harmed, assaulted by stalkers. I, Steven Gammill state that my life has been ruined as I am no longer employable, I am workplace mobbed, my work is being damaged, my family is being threatened, etc.

QUESTION HERE: I HAVE FILED A TORT 95 CLAIM? IF NOT WHY, IS IT THE LIMIT OF DOLLAR DAMAGE TO YOUR LIFE OF THE CONCERN FOR MY TARGETING OF YOUR LIFE AS TORT FILINGS WITH DOCUMENTED DAMAGES DO APPLY IN OUR CASES WHERE LOSS HAS OCCURRED.

I am or have become a victim of (torture, attacks, assaults, harassment, sexual abuse, police abuse, government funded technology abuse, etc.), and am now aware that these technologies are being funded by the United States government with most of these technologies being developed for war are also now being tested and evaluated per Department of Defense Directive 5240.1-r - Procedure 13 - Human Experimentation (on U.S. Persons and others) for Intelligence Purposes. As a human being and with Human Rights I have not given approval for the use or abuse of my body in any form to anyone or to any entity within or outside of the United States government to include any corporation, researcher, scientist, military agency or anyone affiliated within or outside of any agency, corporation or individual that has resulted in the harms that my body, life, property, career and or finances have endured. To further state that military training documents such as the Department of Defense Joint Targeting Publication https://www.aclu.org/files/dronefoia/dod/drone_dod_lp3_60.pdf; DOD Joint Targeting of Individual and Groups that involves the United States 'Joint Chiefs of Command' and the United States (HHS) Health and Human Services involvement, an agency that oversee the medical records of every citizen along with citizens who are being used illegally for testing and evaluation of war technologies;

I the Affiant of this Affidavit do object to such treatment and abuse of my body and life. In addition to the above noted military training documents that is resulting in the harm to myself and to millions of citizens of this country I do as well object to the Department of Defense Directive 5240.1-r - Procedure 13 that has resulted in the destruction of my health as will where this document has existed for decades with no oversight yet it still exists as a published and available document resulting in harm to myself and millions of citizens. The chapter 13 reads as follows:

C13. CHAPTER 13 PROCEDURE 13. EXPERIMENTATION ON HUMAN SUBJECTS FOR INTELLIGENCE PURPOSES

C13.1. APPLICABILITY This procedure applies to experimentation on human subjects if such experimentation is conducted by or on behalf of a DoD intelligence component. This procedure does not apply to experimentation on animal subjects.

C13.2. EXPLANATION OF UNDEFINED TERMS C13.2.1. Experimentation in this context means any research or testing activity involving human subjects that may expose such subjects to the possibility of permanent or temporary injury (including physical or psychological damage and damage to the reputation of such persons) beyond the risks of injury to which such subjects are ordinarily exposed in their daily lives.

C13.2.2. Experimentation is conducted on behalf of a DoD intelligence component if it is conducted under contract to that component or to another DoD Component for the benefit of the intelligence component or at the request of such a component regardless of the existence of a contractual relationship.

C13.2.3. Human subjects in this context includes any person whether or not such person is a United States person. C13.3. PROCEDURES C13.3.1. Experimentation on human subjects conducted by or on behalf of a DoD intelligence component may be undertaken only with the informed consent of the subject, in accordance with guidelines issued by the Department of Health and Human Services, setting out conditions that safeguard the welfare of such subjects. 
